What was the final contract?

The puzzle could also be stated, "What is the only game contract that is makeable against best defence?" The most obvious candidate is 3NT. There are seven top tricks, and declarer can establish an eighth by playing on hearts or diamonds. but there is no way to come to a ninth trick against proper defence. No matter how well you play, it can't be made.

What about four hearts in the 5-2 trump fit? Eight tricks are easy - three natural trump tricks plus the aces and kings in the side suits - and declarer can score a ninth with careful play. but a 10th trick will elude even the finest declarer. Try again.

Five clubs? Or five diamonds? Either seems highly improbable since an additional trick is required. And you're right. five of a minor is out of the question. Well, what's left? You guessed it! After a few cocktails, Mabel was feeling a little tipsy and accidentally opened the bidding in the wrong suit. The auction went:

S	W	N	E
♠	p	2♦	p
2♥	p	4♠	

Yes, the game in spades is the only one that makes - on a 3-2 fit! The opening lead was a trump (best) and Mabel won the ace in dummy. She cashed the top cards in each side suit ending in her hand, then ruffed a heart with the eight, ruffed a diamond with the ten, and ruffed a heart with the nine. The defence was helpless to stop it.

Responding to Partner's One of a Major Opening

Twenty odd years ago the accent of suit bidding changed – instead of being based on the combined number of points that you had, auctions became much more concerned with the combined length of the agreed trump suit, and useful shortages.

The rule then was that with a combined nine card fit and half the points you happily competed to the three level, with just an eight card fit you conceded that level to the opponents.

With this in mind American player Marty Bergen introduced (and did very well from) the concept of Bergen raises, where after partner's major opening an immediate 3♣ response showed four card support and 6-9 high card points, while 3♦ showed 9-11. A 2NT response showed four card support and game values, more about that later.

This worked comparatively well, being attuned to the thinking then and now, however the convention had problems when responder had a near opening hand and three card support. Bergen's choice was to bid 2♠ with such a hand opposite partner's 1♥ opening, and 3♥ opposite 1♠. Such a treatment often left pairs one level higher than they would have preferred, (particularly with light openings being in vogue) whilst excluding other possibly more useful meanings for such a call.

The fact that most were playing 2/1, where a new suit call at the two level was game forcing also precluded a temporising call followed by a delayed invitational raise.

So, it was out of necessity that the immediate 2♣ response was amended to either have its usual meaning, or else a prepared three card raise. In response a simple rebid of the opened suit indicates a minimum opening, any other call possibly showing extra values. For example:

1♠ 2♣

2♠ Weak, wouldn't accept a game invite

1♠ 2♣

2♦ may be temporising by opener, too strong to rebid 2♠, not keen on 2NT

1♠ 2♣

2♥ Natural, may still have a weak hand

1♠ 2♣

2NT 13+, game forcing, would accept a game invite

1♠ 2♣

3♣ must have extras, due to the uncertainty of the 2♣ response

1♠ 2♣

2♦ 2♠ -Responder has an invitational raise

1♠ 2♣

2♥ 3♠ – game forcing, stronger than 4♠

1♠ 2♣

2♦ 2NT – game forcing

How should you proceed with those hands where responder has game values, and possible slam interest? First, you can go via the two examples immediately above, where responder has shown game values, leaving it to opener to bid on with extras.

Alternatively, with four card support and game values, responder can bid an immediate 2NT, showing this specific hand. There are various conventions then available, I play that opener shows a shortage by bidding that suit, indicates a minimum by rebidding 3NT or four of the agreed major, all other rebids showing extra values.

When the Opponents Don't Know Their System

You are having a contested auction, and an opponent makes a call. You ask the opponent's partner what the bid means, and he is uncertain. What do you do now?

Call the Director! If your question is a reasonable one the Director will send the unknowing partner away from the table and then ask the player who made the call of the conventional meaning, if there is one.

The player who made the call cannot, of course, draw any inference from partner's failure to remember the meaning of the call. Further, only the Director can send a player from the table, no matter how much their opponents or even partner may wish to do so.

When Partner Doesn't Know Your System

This becomes a matter of priorities - you naturally wish to give the proper information to the opponents; however you must not do so while partner can take advantage of the correction.

Therefore, you cannot correct the misinformation during the auction. If your side is declaring on the hand, you should inform the opponents of the true meaning of the call before the opening lead is made. If instead your side is defending, then you cannot tell the opponents until the play is concluded.

In both instances the Director should be summoned at the end of the hand if the misinformation may have caused any damage to your opponents.

Create Your Own Convention Card

The ABF Convention Card is easy to edit, using Adobe Acrobat. You can download a draft version of a Standard convention card from our website ("For Members", then "Standard Convention card") or directly there from this newsletter since it is at <http://www.bridgeinthecity.net.au/Standard.pdf>

Having downloaded the form, you should save it in a folder on your computer, then open it using Acrobat DC10.

Next you begin editing it to your own personal choices. Suit symbols are inserted by using exclamation mark and then the first letter, so !c for club, !h for heart, etc.

When you are finished save it first, then ask for it to be printed. The two pages will usually be printed back to back, without your asking. For your other partnership, open this file again, make the necessary changes, and save it under the name of the new pairing.

Michael's Cue Bids

Michael's cue bids are used as overcalls to show two five card suits, strength to be determined.

As an example, if your right hand opponent opens one of a major, two of the same major shows five+ cards in the other major, and five+ cards in one of the minors, while a jump 2NT overcall promises both minors.

If instead your right hand opponent opens one of a minor, as a natural call, then two of the same minor promises five cards in each of the majors, while 2NT promises five + cards in the two lowest suits.

An alternative to this is to play two of the bid minor as showing the other minor and one of the majors, while 2NT shows both majors. This has the disadvantage of forcing you to the three level with both majors.

I haven't mentioned the high card points for such a call. First, points in your two suits are valuable, while outside honour cards, apart from Aces, are usually worthless, responder should judge his hand accordingly. A Michael's cue bid can be wide ranging in values, from a hand that is being used to pre-empt the opponents to one with game values. In general the minimum strength should be determined by the vulnerability, with responder being able to invite using a cue bid opposite a 2NT call (1♥ 2♥ P 2NT), or 2NT opposite a cue (1♥2NT P 3♥).

When the Auction is Finished

The auction ends after three consecutive passes.

- The player to declarer's left tables the opening lead face down.
- Declarer and the other defender may then ask questions about the auction.
- The opening lead is turned face up.
- Dummy comes down.
- All bidding cards are returned to the bidding boxes. (It is permissible to leave the final contract out)

This ensures that all players have access to the auction for clarification before play begins. Premature removal of bidding cards can interfere with proper explanations and may violate etiquette or laws of the game.

Prepayment Scheme

Clarence Gardens Bridge Centre has its own prepayment scheme, allowing players to pay their table fees in advance.

Players then get a weekly email advising them of their balance, while containing a link to an internet schedule of all their deposits and deductions.

Payments can be made either to the Director on duty, or else online into the following Bridge in the City bank account. BSB 805-050, account number 102-790-715

It's your opening lead against contracts of 1NT and 2♠. Having decided to lead this suit, which card should you play?

QJ76 NT 6, Suit Q

KQJ53 King, always

Q1094 NT 4, Suit 10

J862 2, always (not a suit I like to lead from)

J1062 NT 2 Suit J

KQ106 King, always

AK54 NT 4, Suit Ace

KQ864 NT 6, Suit K
